

# Special Meeting

## August 31, 2020

1. **CALL TO ORDER:** Mayor Norby called the Special Meeting of the Sidney City Council to order at 6:30pm.
2. **PLEDGE OF ALLEGIANCE:** The Pledge of Allegiance was stated by all present.
3. **ALDERMEN PRESENT:** Christensen, Koffler, Rasmussen and Sergent

5. **Public Hearing-Fiscal Year 2020-21 Budget:** Mayor Norby called the public hearing for the Fiscal Year 2020-21 budget to order at 6:31pm. Clerk/Treasurer Chamberlin stated there has only been one change to the preliminary budget. She stated the Police CIP expenditures needed to be increased from \$15,000 to \$25,000. She stated this is due to the increased costs of purchasing the guns and ammunition for the police department, and that there is \$35,000 cash in this fund that will cover all of the expenditures. She also stated Chief Kraft is selling the previous guns and guns and ammunition from the evidence locker, and that revenue will be going into the Police CIP fund to recoup costs.
