5. **Public Hearing:** City Clerk/Treasurer Redfield provided the City Council with fiscal year 2018-19 budget presentation. Motion was made to approve Resolution Number 3775 by Alderwoman Christensen, and seconded by Alderwoman Rasmussen. After no discussion, all present voted aye.
  - b. **Resolution No. 3776-Assessing a property tax to defray the cost of maintaining and furnishing street lighting-residential:** Attorney DeCrescente read Resolution Number 3776, assessing a property tax to defray the cost of maintaining and furnishing street lighting for residential, out loud. Motion was made to approve Resolution No. 3776 by Alderwoman Sergent, and seconded by Alderman Smith. After no discussion, all present voted aye.
  - c. **Resolution No. 3777-Assessing a property tax to defray the cost of maintaining and furnishing street lighting-commercial:** Attorney DeCrescente read Resolution Number 3777, assessing a property tax to defray the cost of maintaining and furnishing street lighting for commercial, out loud.
