- 14. CHIEF OF POLICE DIFONZO:
 - a. Report-September 2017: Travis Roseaan was reporting on behalf of Chief DiFonzo, he stated that the new MDU pole over by the SW corner of Lincoln and 7th Ave will have no obstruction of view if vehicles come to a complete stop at the white cross lane. Everyone will just have to take extra caution when approaching that intersection from now on. MDU mentioned that the gas is nonflammable and will no health issues to the citizens here in Sidney, people will be smelling the gas and to be expected to take phone calls that day.

15. PUBLIC WORKS DIRECTOR HINTZ:

- Report- September 2017: PWD Hintz provided this monthly report for September 2017, and stated that
 there was 325.0 hours of street repair and 150.0 hours of mowing, and 138.5 hours of street sweeping.
- b. Take part in your parks Veteran's Park Arch Project by Eagle Scouts: PWD mention that by December 1st, 2017 the arch project will be completed, PWD is asking the council for approval of this project by the Eagle Scouts. Alderwoman Rasmussen made a motion to approve this project, and seconded by Alderwoman Sergent. After no further discussion, all present voted aye.
- c. Update on the Holly Street MDT Project: PWD Hintz said he did a complete walk through of east holly with the MDT and it will be a three lane with all new curb/gutter and a storm sewer system. City and county both donated a lot of money towards this project, 2018 is when the project start to take place. Agri-Industries will be starting next year, and in the spring of 2019 is when the actual construction of the project will begin.
